Import

Manage all types of shipments and split Master Airwaybills in separate documents (House Airwaybill). Also, reserve storage and transportation towards the receiver directly from the software.

Register data

Register all relevant data of the shipment. From sender, receiver and carrier to ETD and ETA. But also the size, weight, packaging, etcetera.

Export

After registration of the shipment data, generate the necessary documents. Such as House Airwaybill, Master Airwaybill and customs documents.

Rates

Rates for airfreight are never standard. Capture complex tariff agreements in the system, so you always have insight into costs and revenues. Through a connection with Cargoguide, it is possible to select up to date rates and easily add these to the shipment.

Customs

Perform automated declaration, where the requisite documentation is generated automatically, providing you continuous insight into the customs process. For airfreight via Schiphol (Amsterdam), our software is connected with Cargonaut (DGVS). Links with other customs systems for the handling of import and export can also be realized quickly.

Documents

For the import and export of goods, specific documents are required to get the goods across the border. Enter data only once and the software simplifies and accelerates work processes, saving you time and providing you better insight.
